Tariffs and the Impact on Renfrew and Lanark Counties

On February 1, newly inaugurated President Trump announced the implementation of immediate 25% tariffs on all Canadian goods. In response, the Canadian government imposed retaliatory tariffs on \$30 billion worth of U.S. goods, with plans for further increases. The sudden move raised concerns about job losses, business closures, and rising costs for Canadian industries.

Now, in a recent update, President Trump has temporarily paused some tariffs until April 2, following pressure from American business leaders who argue the trade war is harming financial markets. However, the pause only applies to Canadian exports that fully comply with the Canada-U.S.-Mexico Agreement (CUSMA), leaving an estimated 62% of Canadian imports still subject to steep levies. Meanwhile, Canada has opted to keep its initial counter-tariffs in place but will delay its next round of retaliatory measures until the U.S. decision on April 2.

The uncertainty surrounding trade relations will continue to impact businesses in Renfrew and Lanark counties, particularly manufacturers in the steel and aluminum sectors. While Canadian exporters may face rising costs, much of the financial burden will still be absorbed by U.S. purchasers. To support local businesses through this volatile period, the County of Renfrew, the Upper Ottawa Valley Chamber of Commerce, and other community organizations are actively engaged. The Labour Market Group (LMG) will closely monitor developments and work with partners to assist those most affected.

These assumptions were derived from unemployment data analysis, employment service office activity, local intelligence from community consultations, and job posting trends across various platforms.

Opened on December 7, 2024, the Mesa Warming Centre provides 24/7 support for individuals facing homelessness and precarious housing. Located at 156 John Street, this collaborative initiative by the County of Renfrew and local partners addresses homelessness, addictions, and mental health challenges.

Staffed by MacKay Manor personnel, the low-barrier facility offers vital services, including addiction and mental health support. Funded through municipal partnerships and generous community donations, the Centre is grateful for the contributions from local businesses and organizations.

Lanark County Joins REDI Pilot to Attract Skilled Workers


Lanark County is proud to be one of four regions participating in the Regional Economic Development through Immigration (REDI) pilot program from January 2 to December 31, 2025. This initiative helps local employers address labour shortages by attracting highly skilled international workers in healthcare, skilled trades, technology, construction, and other in-demand sectors.


Employers can take advantage of a streamlined immigration process through the Ontario Immigrant Nominee Program (OINP) Employer Job Offer streams, while internationally trained workers can secure employment and a pathway to permanent residency. Labour Market Data: Lanark and Renfrew December 2024 to February 2025


FASTEST GROWING INDUSTRY AT THE 2-DIGIT NAICS LEVEL







These graphs show the highest paying industries according to a place of work status at the 2-digit NAICS classification in Renfrew and Lanark Counties.




